

# Infrastructure Development Strategy

We conduct infrastructure needs assessments, prepare infrastructure development strategies and plans, and advice clients on the full range of public and private funding options for infrastructure based on a structured integrated planning framework for infrastructure development. We also assist clients to identify optimum infrastructure delivery phasing approaches, carry out project and programme screening, develop pipeline of projects and establish responsibilities for delivery.

Our services include identifying opportunities, risks, challenges, merits and demerits and advising on implementation and mitigation approaches for infrastructure development. We also address issues deterring investment in infrastructure, such as coordination problems, front-end costs and risks and lack of sustainability. Our services cut across the full range of infrastructure financing approaches:

- Public sector financing: We advise on effective funding of infrastructure through government budgetary sources from revenues and borrowing (bonds, loans) and non-budgetary sources such as bilateral / multilateral development agencies.
- Private sector financing: We advise on harnessing domestic and external sources of private financing for
  infrastructure such as infrastructure funds and investors, commercial banks, debt and equity capital markets,
  bonds, private equity funds, sovereign wealth funds, development finance institutions, donors, and pensions and
  insurance funds.
- Islamic Finance: We also advice on the funding of infrastructure through Islamic finance mechanisms such as sukuk bonds, murabaha, musharaka, mudaraba, ijarah, istisna'a, salam, etc and ensuring the right balance of benefits (returns) and liabilities (risk) for investment participants and avoidance of interest in accordance with Islamic jurisprudence.
- Alternative funding mechanisms such as sponsorships, innovative transport revenues and incentives, government service partnerships and funding partnerships.

We assist clients in identifying avenues for addressing challenges related to inadequate sources of affordable long-term equity and debt financing mechanisms, limited sources of credit enhancement instruments as well as the utilisation of infrastructure project development facilities.

Our services include advising on strategic infrastructure asset management aimed at achieving sustainable infrastructure investments.

# **Project and Programme Management**

We provide structured project and programme management based on a project life-cycle approach so as to ensure that our client's objectives are met. The services we render are designed to suit the requirements of each specific project or programme and may be offered for all or any of the project life-cycle phases, viz. initiation, planning, implementation (execution) and closing phase.

In providing our project and programme management services, we utilise best practice methodology, processes, procedures and technology to ensure:

- an effective project strategy and governance structure geared towards meeting project objectives is established.
- timely completion of the project through management of the contractors' submittals, effective controls, processes and reporting.
- that constructed works are delivered in accordance with the client requirements, contract specifications and to the international codes and standards of practice.
- that the project cost is within the anticipated budget through the implementation of a cost control scheme and early anticipation and analysis of the risk factors.



# **Procurement and Cost Management**

We advise on procurement strategy and plans, develop suitable procurement methods and procedures for projects and programmes, produce tender and contract documents, provide tendering advice and reporting, establish optimum parameters for contract negotiation and selection of contractors and service providers as well as the establishment of contract sum.

Our cost management (quantity surveying) services include cost planning and estimating at design stage, cost modelling and scheduling, preparation of pricing documents and bills of quantities as well as lifecycle costing.

During construction and operational phases, we institute cost control mechanisms, manage variations and developer/contractor's claims, prepare valuation of work in progress for interim payments, monitor fund utilisation, prepare and settle final accounts and costs.

We also monitor and review project performance, carry out procurement audits, identify and advice on long lead items and other critical issues such as electrical, mechanical and other infrastructure components requiring effective procurement and purchase approaches to avoid project delays and ensure value for money is achieved.

# **PPP Transaction Advisory Services**

We provide PPP transaction advisory services to suit various client needs including government, infrastructure investors and lenders as well as DFIs and international / regional development organisations. These services aim to enable the development of infrastructure based on the principles of value for money, optimum risk sharing and consideration of public interest.

The services cut across the lifecycle of PPP projects from strategy phase, through to conceptual, procurement, and construction and operational phases.

For governments, the services are geared towards helping to create an enabling environment for private investment in infrastructure, screening projects to identify those suitable for PPP, transaction support to prepare feasibility studies and business cases, managing the procurement process, support for negotiations, achieving contract and financial close and advising on project implementation (construction and operation) so as to ensure infrastructure provides a positive impact on the society.

The Phase III—Part I of the National Assembly Office Complex consists of 2 separate office complexes measuring 100,000sq.m in gross floor area, to accommodate about 93 Senate and 200 Federal House of Representative members of the country, including their staff. The development could not commence due to perceived high cost amongst other issues. Murty was commissioned by FCTA/FCDA to review the project and contract that had been signed with the Contractor and proffer solutions to facilitate a successful implementation.

We conducted an independent project review and audit as well as cost and contract analysis. This involved checking the contractor's submission for the project, auditing project drawings to establish its completeness, preparing bills of quantities, establishment of Foreign/Local Content Ratio, analysis of contractual arrangements amongst other things.

We developed a project and contract strategy that formed the basis for renegotiations between FCTA/FCDA and the design and build contractor, and established a Project Governance Structure for managing the project . We also provided advice and guidance during contract renegotiations and prepared the new contract documentation. The project adopted a design and build procurement method, with contract sum of N21.00 billion (US\$156million).
